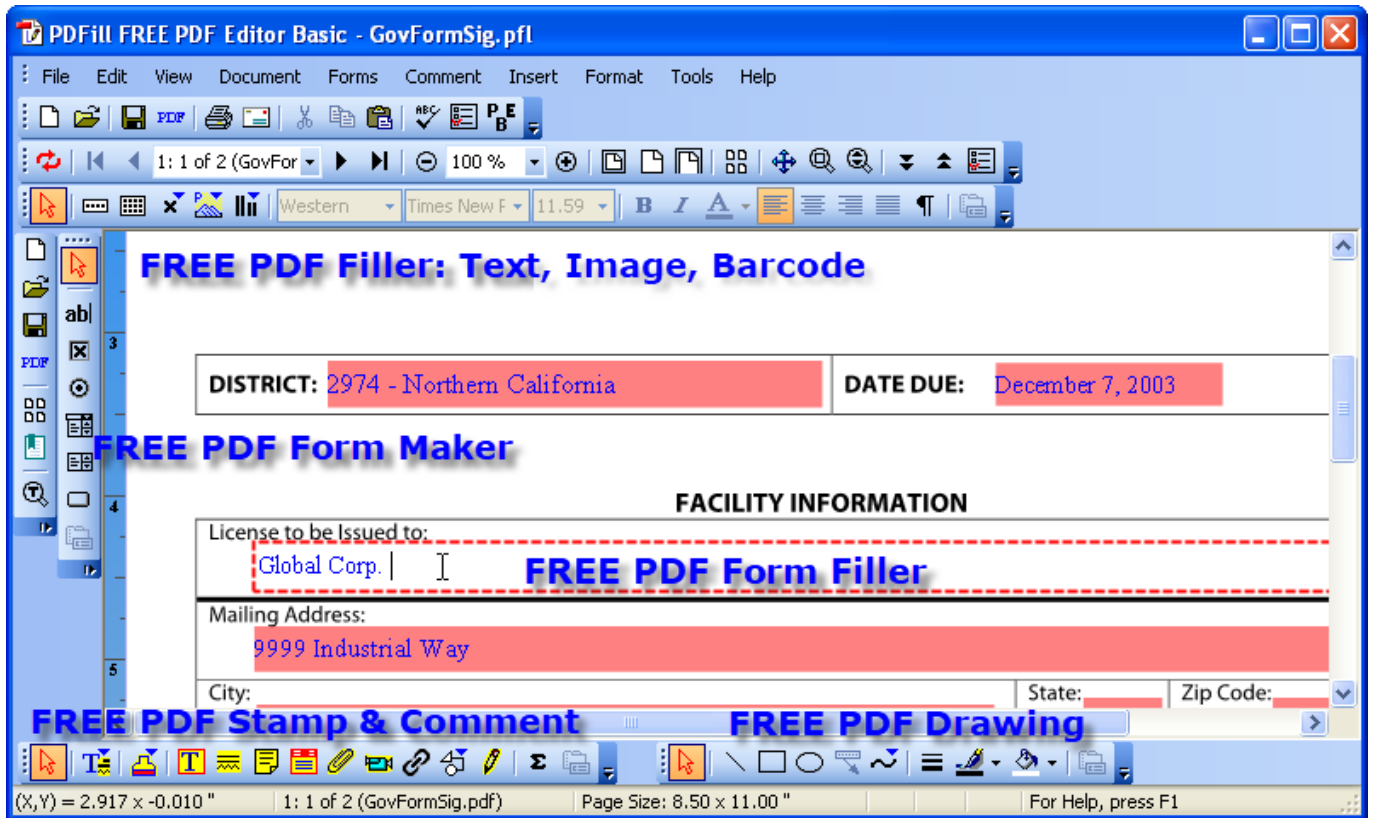

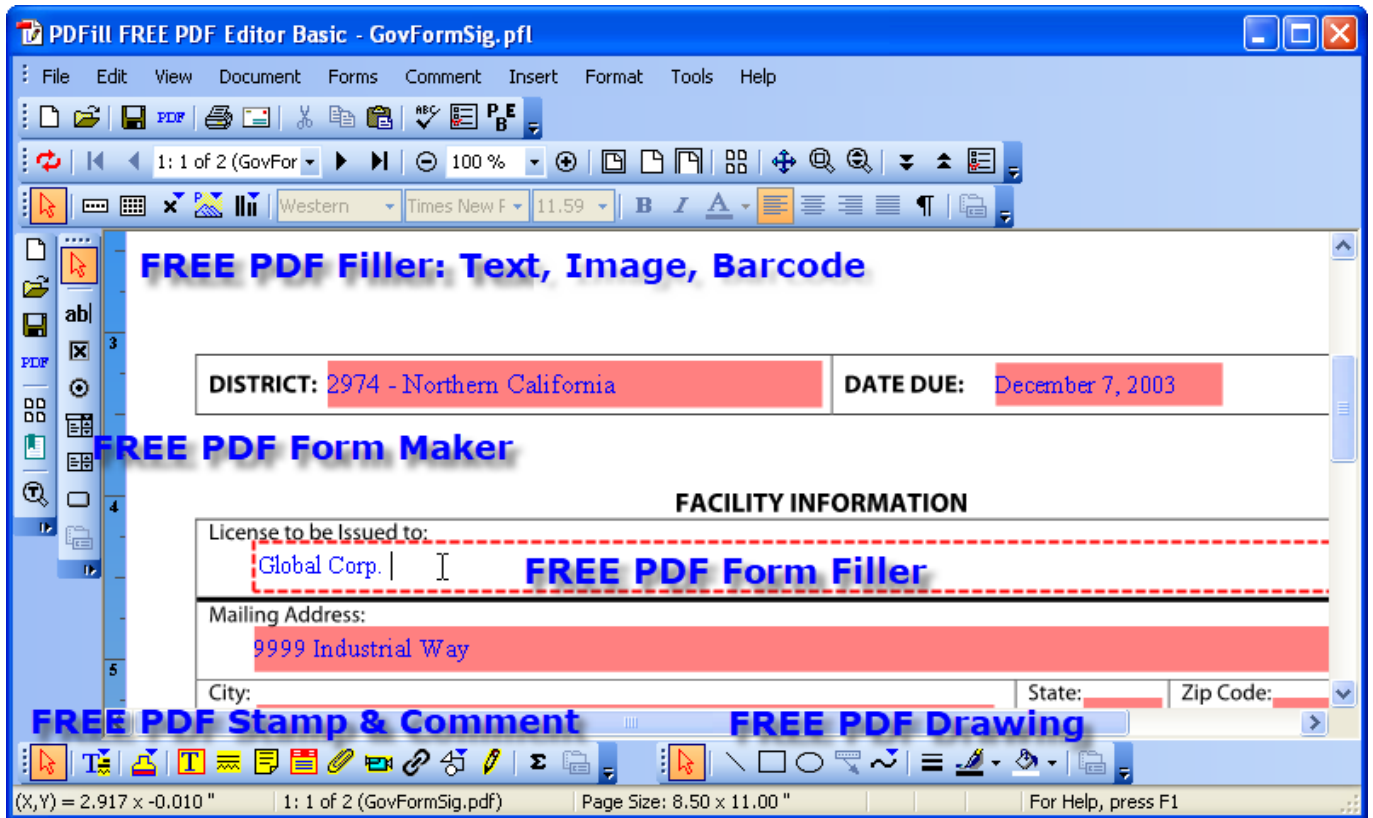

However you need to follow the instructions carefully Generally, you need to apply to the IRS for a new Employer Identification Number, or EIN, for any new business.. However, under certain conditions, you can use a previous EIN, such as for a limited liability company or a partnership.
